## Regulations for the Award of the University of Winchester Scholarships to International Students

## General

1. University of Winchester awards Scholarships to international students who satisfy the specified criteria. The Scholarships constitute a reduction in tuition fees of no more than £1,000 per annum.

### Eligibility

2. To be considered for the award of a scholarship, applicants must meet the following criteria for residence and academic standing: they must be foreign nationals of a country outside the European Union or British Nationals whose residence history makes them liable to pay tuition fees as international students.

Only applicants applying for full-time programmes at Undergraduate or Taught Postgraduate Level are eligible. Applicants for ELTSU programmes (including the International Foundation Programme and the Certificate in English for International Students) are not eligible.

### Regulations

- 3. The Scholarship application will be considered only when a firm offer of a University place on a fulltime programme of study is made to the applicant.
- 4. Scholarships are not linked to specific courses. In the case of the candidates applying for more than one course, only one Scholarship application can be considered for that candidate.
- 5. Applicants will be required to enclose with their application:
  - (a) photocopies of their qualifications, which must carry the verification stamp of the awarding body;
  - (b) a letter of confirmation from the candidates last educational institution that the qualifications were gained.
- 6. Applications will be considered by the University's Scholarship Committee at its June meeting. Because of the short time available for the decisions to be communicated to applicants, the Committee reserves the right not to consider any application which does not include the required information/verifications.
- 7. The Committee will only consider applications from eligible candidates (see paragraph 2 above). The Committee will employ the following criteria in considering which students will receive the award of a Scholarship. The Committee will do so on the basis of factual information on the application, the supporting statement from the application, and any further statement specifically to support the application for a Scholarship received by the due date. The criteria below are treated equally, and an indication of the aspects that the Committee will be looking for is shown.

#### Academic track record

The Committee will expect to see evidence of relevant academic qualifications and experience.

#### Ability to exploit their chosen degree path on return to home country.

The Committee welcomes applications from students who will make the maximum use of the qualification gained at the University for either personal or community benefit.

## Commitment to University of Winchester as opposed to other institutions.

The Committee welcomes applications from students recognising the distinctiveness of University of Winchester and its programmes of study.

## Enthusiasm for education

The Committee welcomes applications which demonstrate an enthusiasm for the challenges and benefits of higher education.

## Suitability for chosen degree path

The Committee welcomes applications from students who are well suited for their chosen qualification and who demonstrate an understanding of the nature of the subject chosen.

- 8. The University of Winchester will inform candidates whether or not they have been successful immediately after the meeting of the Scholarship Committee. Successful candidates will be expected to send written acceptance of an offer of a Scholarship within four weeks of the meeting of the Scholarship Committee. If such acceptance is not received by the due date, the Scholarship will be offered to another candidate. Scholarship candidates should therefore ensure that they are in a position to receive and respond rapidly to mail during the stated period.
- 9. Successful candidates will be expected to present the certification (confirming letter) of their award to the Finance Department on the first day of the first semester of their attendance at the University of Winchester.
- 10. Scholarships will constitute a yearly reduction in the tuition fee payable by the student of no more than £1000 per annum, normally for the duration of the course, subject to a satisfactory annual performance report review.
- 11. The Committee reserves the right to rescind the award in instances where students change course from their original choice, upon which the candidate's suitability was assessed.
- 12. The deadline for completed application forms, for the forthcoming academic year, is 30 June unless notified otherwise.
